#### **AMTSO Standard Compliance Statement**

This test and the test plan below has been designed by Virus Bulletin Ltd to comply with the Anti-Malware Testing Standards Organization, Inc. ("AMTSO") Testing Protocol Standard for the Testing of Anti-Malware Solutions, Version 1.3.

#### Introduction

VBSpam is a continuously running comparative test programme for email security solutions. The test seeks to measure and compare the performance metrics of the publicly tested email security solutions.

## **Test methodology**

The test follows the 3.0 version of the VBSpam test methodology, published at:

Among others, the methodology document details:

- Testing process
- Test scope / functionality of the products tested
- Test environment
- Test case curation and selection
- Certification criteria and test scoring
- Acceptable product types and configurations
- Feedback (including types of test evidence provided) and dispute policy
- Opt-out and test invalidation policy

## **Participants**

Participation in the test is available in the following models:

- A vendor may choose to join the test programme on a commissioned and paid basis. This
  provides continuous testing for the product for a year, with four periods designated as
  official testing periods. Data collected in these periods forms the basis of the public test
  reports. Outside of these periods, feedback is provided privately to the vendor.
- Virus Bulletin may invite a vendor to join VBSpam for a specific public test at its own
  discretion, free of charge. Invited vendors are provided with the same rights and services
  as those tested on a commissioned basis, however the arrangement is only for the
  duration of the process required to set up, test and dismantle the product.

## **Schedule**

The schedule for this test is as follows:

Event	When	Notes
Vendor notification	At least 10 calendar days before the test commencement	Vendors are notified by email about their upcoming test. They are invited to send any updated product builds, configuration instructions, new contact details, etc. in a formal manner. Virus Bulletin also provides the opportunity to audit the product configuration in the test environment at this point.
Live test commencement	November 2, 2024	Live testing period begins. Products are subjected to test cases as described in the Test Methodology. Note that no feedback is provided during the live testing.
End of live testing period	November 17, 2024	Live testing period ends.
Feedback	November 18, 2024	Preliminary test results (for their product only) are shared with the vendor. The release of this data marks the beginning of the vendor feedback period.

Vendor feedback (dispute) period	November 29, 2024	Vendors are invited to provide feedback on their test results and to engage in conversation with Virus Bulletin if they have any objections.
Report release and status update	No later than December 20, 2024	The final test report is released on Virus Bulletin's website.

Virus Bulletin endeavours to communicate any significant deviations from the above general schedule to the affected vendors in a timely manner.

## **Attestation**
